They are not a 'tick-box' exercise, they are a learning exercise and students really value timely, focused feedback. So next time a student asks you to observe them, remember it is about helping them to improve and to learn from you, so please take the 10 minutes or so to stop, watch and give feedback. Effective feedback needs to be focused – give them at least one thing to work on next time.

The Wide Bay Public Health Unit would like to thank colleagues across the region for your support this year. The pandemic isn't over, and the coming months will throw up more challenges, so I would encourage everyone to remain vigilant and maintain a low threshold for testing.

Also of note, we've seen lots of gastroenteritis this year. The public health unit spends a great deal of time investigating and managing outbreaks and clusters of diarrhoeal disease. As always, it's very helpful for us if patients can have a stool sent to the lab when they're unwell. I appreciate that's not always practical. However, it's particularly useful if the patient lives in residential care or has recently eaten out. Knowing the causative organism helps us to link patients in an outbreak and to track down infective sources.
